**MINUTES OF THE STATE DEVELOPMENT REFORMS COMMISSION (SDRC) HELD ON  
23-02-2006 AT 11.00 A.M IN THE CONFERENCE HALL, MAIN SECRETARIAT BUILDING**

The meeting was chaired by Shri E.K. Mawlong, Chairman SDRC, who welcomed all the Members and officers present. He informed that the last meeting was held in July 2005 and no meeting had since been held pending sanction of the required amount (Rs. 2.50 lakhs) for meeting the expenses of the Conference/Workshop on Pollution. The Chairman suggested prior to the Conference/Workshop, a meeting with the experts/officials of different departments concerned may be held on the 6<sup>th</sup> April 2006 to finalize and chalk out other details.

After a thorough discussion, the following action points were taken :-

1. The Commissioner & Secretary, Programme Implementation & Evaluation Department and Member Secretary, SDRC should take up the matter with Finance Department for withdrawal of the sanctioned amount of Rs. 2.50 lakhs before 31<sup>st</sup> March 2006.
2. The next meeting of the Commission with the experts/officials of different Departments concerned will be held on the 6<sup>th</sup> April 2006.
3. The Conference/Workshop will be held at Pinewood Hotel.
4. Programme Implementation & Evaluation Department to immediately issue letters to all concerned Departments to prepare details & data (district-wise) on the impact of pollution and to submit the same before the next meeting.
5. Health Department to submit a report/data (district-wise) on the impact of pollution in the coal mining areas.
6. The Commission proposes to undertake field visit/inspection of the Byrnihat Industrial Estate and Lumshnong area to oversee the impact of pollution.
