OFFICE MEMORANDUM

Dated Shillong, the 22nd October 2010

No. PIA/SDRC/6/2010/6 :- The State Development Reforms Commission constituted vide this Department Notification letter No.PIA/SDRC/1/2000/2 dt. 08.03.2000 and re-constituted vide this Department Notification letter No. PIA/SDRC/1/2003/Pt./19 dt. 03.08.2010 shall henceforth be governed by the following rules and regulation:-

1. COMPOSITION:-

- (a) Chairman ----- No. (1)
- (b) Co- Chairman/Deputy - Chairman/
Vice-Chairman ----- Nos. (5)
- (c) Non Official Member ----- Nos. (Not more than 7, preferably one
from each District)
- (d) Official Member ----- Nos. (3)
- (e) Member Secretary----- No. (1)

2. ELIGIBILITY:-

- (a) **Chairman :-** Sitting Member of Legislative Assembly(MLA) to be nominated by the Chief Minister.
- (b) **Vice - Chairman/Deputy Chairman :-** Ex - Member of Parliament(MP) & Ex - Member of Legislative Assembly(MLA) to be nominated by the Chief Minister.
- (c) **Non - Official Members :-** Not more than ----- Nos of persons with known contribution in the field of development to be nominated by that Chairman.
- (d) **Official Members:-** The Additional Chief Secretary/ Principal Secretary/Commissioner & Secretary of Planning/Programme Implementation & Evaluation and Finance Departments.
- (e) **Member Secretary:-** Any Officer not below the rank of Under Secretary.

3. TENURE:-

The term of office will be generally for 2(two) year for (a), (b) ,(c),(d) & (e) of para 1. above.

4. FUNCTION:-

The Terms of Reference of the Commission shall be as follows:-

- (a) To examine the parametres of ongoing developmental programmes, from time to time, with a view to determine whether such programmes have been/ are achieving the desired results. If not, to suggest suitable modifications thereof with a view to ensure their effectivity .
 - (c) To examine the need for undertaking new programmes for accelerated development of the rural areas with particular emphasis on poverty alleviation and to suggest working parametres thereof, from time to time.
 - (d) Any matters ancilliary thereto.
5. Payment of Honorarium & facalities,T.A./D.A. etc. :- As per Govt., Orders issued from time to time.
6. The Commission should submit an Annual Report to the Govt., every year.
